About MCRF

The Midwest Cardiovascular Research Foundation (MCRF) is a non-profit, public, charitable organization that seeks to improve and prolong the quality of life in the communities we serve by conducting and disseminating findings of high-quality cardiovascular clinical research.

Founded in 2002 by Dr. Nicolas W. Shammas, MD, the Foundation is a consortium of affiliate medical research sites, located in the Midwestern US, conducting largescale clinical cardiovascular trials that no single site would be able to conduct alone and performing regional educational activities for health care personnel and the general public on the recognition and prevention of heart disease.

MCRF – History in the Making

The Midwest Cardiovascular Research Foundation (MCRF) was envisioned by Dr. Nicolas W. Shammas in December 2001. The rationale to have such a foundation was simple: despite a tremendous growth

in technology in the cardiovascular field, heart disease remains the #1 killer in the United States. There are now more unanswered questions than ever, and as more knowledge accumulates, the questions continue to multiply.

In order to improve and prolong people's lives, we are in need of more definitive answers to rapidly emerging questions that can come only from well-designed and well-conducted clinical research.

Despite the fact that centers of excellence for clinical research such as C5, DCRI, the TIMI group and others have created a wonderful, sophisticated machinery to achieve these goals, nonetheless the feasibility of one center successfully conducting an outcome trial is virtually impossible.

Addressing Needs in the Midwest – In the central Midwest, we have lacked this ability, despite the presence of very sophisticated clinical research sites in our community. Thus, the idea of MCRF was developed with the higher mission of improving and prolonging the lives of people in the communities we serve by developing a consortium of research sites from across the Midwest with a central coordinating and business center that can initiate, conduct, analyze, publish and disseminate clinical trials.


MCRF Publications


Professional Development Opportunities

Cardiovascular Interventions and Practice Guidelines 2004, the inaugural conference of MCRF, will be held at the Lincolnshire Resort hotel in Lincolnshire, Illinois, August 5-6, 2004. A distinguished panel of speakers will conduct a day-and-a-half program that includes didactic, up-to-date information on the current status and the future cardiovascular direction of medicine. Also, a total of 15 abstracts and case studies will be presented in poster format. Panel discussion will allow interaction with multiple experts.

Research

MCRF recently launched its MCRF Interventional Registry, focusing on the endovascular treatment of peripheral vascular disease. The purpose of the Registry is to gather effectiveness and safety data for the various peripheral procedures performed at the Genesis Heart Institute (GHI), Davenport, IA. MCRF is planning to expand to a multi-center registry involving affiliates and other participants. The registry will provide a wealth of knowledge of data collected prospectively and will help investigators in the network to obtain answers or formulate hypotheses for many of the questions related to peripheral angioplasty. The registry focus currently is on in-hospital outcomes of peripheral interventions. Currently the registry is supported by the GHI research fund and MCRF.

Recently, Dr. Nicolas W. Shammas was also an invited speaker to the International College of Angiology, where he presented original research conducted by the Foundation's investigators. Dr. Shammas is an officer of the College and on the editorial board of its journal, *The International Journal of Angiology*.



The conference is multidisciplinary and will be of interest to endovascular specialists, general cardiologists, primary care providers, fellows-intraining, cardiovascular nurses and nurse practitioners.

The CIPG 2004 conference is jointly sponsored by the University of Illinois at Chicago, the CME provider of the conference, and MCRF. Co-chairs are Dr. Nicolas W. Shammas, MS, MD, President and Research Director of

MCRF, and Dr. George T. Kondos, Associate Director of Cardiology at the University of Chicago.

Establishing the Legal Structure – Once the MCRF preliminary By-laws and organizational structure were developed by Dr. Shammas, the concept and initial draft of the By-laws were discussed in February 2002 in a meeting attended by Dr. Jon Lemke, Biostatistics; Mr. Steve Fish; Mr. Peter Benson, JD; Dr. Shauna Roberts and Dr. Eric Dippel. After an enthusiastic response, the Foundation's legal By-laws were drafted, and an application was filed with the State of Iowa to register the Foundation and obtain an

Employment Identification Number (EIN). On August 16, 2002, the Foundation was officially registered with the State of Iowa.

Forming the Board of Directors – As the By-laws called for a Board of Directors composed of representatives from various Midwest affiliate sites, Dr. Shammas met with representatives of various Midwest groups at the Chicago Sheraton in November 2002 to refine the conceptual framework and fine-tune the By-laws accordingly. Additional revision of By-laws occurred in February 2003 and will occur again in August 2004.

Developing Relationships with Affiliates – The Genesis Heart Institute, Davenport, Iowa, was the first site to sign on as an affiliate, in Spring 2003, represented on the Board by Dr. Dippel and Mr. Fish.

In September 2003, the CGH Hospital, Sterling-Rock Falls, Illinois, became an affiliate, represented on the Board by Dr. Peter Toth and Dr. Girish Bhatt.

Establishing Foundation Headquarters – In November 2003, the Foundation hired Ms. Shari Lemke as Executive Research Administrator and moved into headquarters on the 7th floor of US Bank, Davenport, in a 2100-square-foot office.

Introducing the Foundation to Community

Leaders \neg The launch of the Foundation was made possible through substantial grant support from the Bechtel Foundation and Trusts (trustee Richard R. Bittner).

Third Affiliate Joins MCRF – In November 2003, the Dakota Clinic/Innovis system, ND became an affiliate. Dr. Edmund Fiksinski and Dr. Tim Mahoney represent the Dakota Clinic/Innovis on the MCRF Board.

501 (c) 3 Status Obtained – With the support of legal counsel Mr. Bruce Hopkins, Mr. Richard Bittner and Mr. Peter Benson, MCRF was granted 501 (c) 3 public charitable status in March 2004.

Assistance in Strategic Planning and

Fund Development \dashv Ms. Joy Thompson was hired as an interim consultant to assist the Foundation to develop strategic plans, seek and obtain grant funding, and begin plans for its first annual conference.

Additions to Core Foundation Staff – MCRF subsequently hired a professional core staff, as well as subcontractors. Staff include Ms. Monica Youngblut, Manager, Clinical Trial Office; Ms. Jan Harper, Project Assistant; and Ms. Maureen Koepke, Executive Secretary. Subcontractors include 3 Ph.D. biostatisticians, informational technologists, legal counsel, CPA, a medical graphic illustrator and designer, and a publications editor and media relations specialist.

Editorial Board Formed – The Editorial Board, composed of physicians from throughout the Midwest, reviews all publications before they are published.

MCRF Responsive and Successful \dashv The many accomplishments of the Foundation are a testimony to the teamwork of the staff, consultants and affiliates and reflect the Foundation's integrity, balance, fairness and willingness to provide genuine help to health care providers and the public.
